- Β. COURSE DESCRIPTION: This course is designed to provide the student with a meaningful occupational experience in dental assisting. A training plan will be developed for each student including three separate rotations in three different dental practices. Two internship rotations will be in a general dental practice and one internship rotation will be in a dental specialty practice. Seminars are part of the required internship experience and attendance is required. Successful completion of this internship is required to graduate from this accredited Dental Assisting Program (Instructor permission required).
