- B. COURSE DESCRIPTION: This course examines screening and assessment tools used by counselors in the substance use field. A major emphasis of this class will be on the practical application of comprehensive assessment and the use of the American Society of Addiction Medicine (ASAM) risk and placement criteria. In addition, students will learn about mental health assessment and screening tools, and their co-occurring relationship with substance use disorders. Motivational interviewing, intake, orientation, service coordination (referral), case management, crisis intervention, client education, ethics, multicultural issues, DSM diagnosis, and treatment planning will also be discussed.
