- B. COURSE DESCRIPTION: This course focuses on developing multicultural awareness and competency as it relates to counseling clients from diverse backgrounds. This course provides students with a general overview of many cultures and subcultures by understanding their history, geographic origin, identity, beliefs, norms, language, and support systems. This course also provides an overview of the counseling skills and techniques necessary to interact with a variety of cultural backgrounds in the addiction counseling field. Emphasis will be placed on the unique treatment needs of individuals from diverse populations and the implementation of consultation and referral when necessary.
